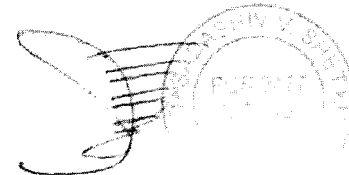

Sub: Delay in processing of Transfer Request.
