Hope this communique finds you in safe and good health. We thank you for your continued patronage as a shareholder of the Company.

SEBI has vide the captioned circular, mandated:

- (i) Furnishing of details of PAN, mobile number, bank account details, specimen signature and nomination by holders of physical securities; and
- (ii) Folios wherein any one of the above cited documents / details are not available <u>on or after October 01, 2023</u>, shall be frozen by the Registrars and Transfer Agent of the Company ("RTA") and you will not be eligible to lodge grievance or avail service request from the RTA and not eligible for receipt of dividend in physical mode.

We have observed from our records that you have not furnished / updated complete details as mentioned above in point (i), hence we request you to furnish the details/documents (Form No. ISR-1, ISR-2, ISR-3 & Form No. SH-13 / 14) as applicable to our RTA's office address mentioned at the end of this letter.

As required by the Income Tax Authorities, please link your PAN with Aadhar by June 30, 2023, or any other date as may be specified by the Central Board of Direct Taxes, if not linked earlier, to avoid freezing of your folio.

Please also note that after December 31, 2025, the frozen folios shall be referred by RTA / Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and / or Prevention of Money Laundering Act, 2002.

The RTA shall revert the frozen folios to normal status upon receipt of all the KYC documents.
