Season's Greetings from **Prima Plastics Limited** ("the Company"). We hope this communique finds you and your family in safe and good health.

We wish to inform you that the Securities and Exchange Board of India (SEBI) has, vide the captioned Circular dated November 3, 2021, mandated the following for all holders of equity shares in physical form:

- a. furnishing of PAN, email address, mobile number, bank account details, specimen signature and nomination by holders of physical securities
- b. any service request shall be entertained only upon registration of the PAN, Bank Account details and Nomination; and
- c. to ensure that your PAN is linked to Aadhaar by March 31, 2022, being the cut off date or such other date as may be specified by the Central Board of Direct Taxes to avoid freezing of your folio.

We observe from our records that you have not furnished some of the mandatory documents/details for your holding in physical form. We request you to furnish the documents/details, as per the table given below, immediately on receipt of this letter.

Freezing of Folios without PAN, KYC details and Nomination:

- a. Physical Folios wherein any one of the aforesaid documents/details are not available on or after April 01, 2023, shall be frozen and you will not be eligible to lodge grievance or avail service request from the RTA and shall not be eligible to receive dividend unless the above documents / details are updated.
- b. <u>After December 31, 2025</u>, the frozen folios shall be referred by the RTA/Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and/or Prevention of Money Laundering Act, 2002.
